New Ulm - Jackie Finstad highlighted the recent silent retreat at St. Francis de Sales, St. Paul. She suggested considering a formal, yet personalized program to re-engage and educate priests about our role in parishes and our Dioceses, heightening greater awareness about who we are and what we do.

St. Cloud – Lois Wesbur reported on behalf of Linda Borgerding. Of the five deaneries, 3 have a full slate of officers and 2 are still seeking them. The Lenten retreat will be held on Sat. March 18 at St. Paul's in St. Cloud. They look forward to the Ordination of their Bishop-elect Patrick Neary in February.
